

Type: Upholstery

Composition: 100 % mohair (pile), cotton (base)

Appearance of the pile will vary

Yarn type: Spun

Binding: Pile

Width: Approx. 140 cm, 55 inches

Weight: Approx. 870 g/lin.m, 28.1 oz/ly

Repeat: None

Cleaning: Vacuum clean frequently, ideally every week.
Remove stains as soon as they occur, with clean warm water or sparkling water. No ironing only steaming. Steaming might be necessary to remove pressure marks. Extraction clean when necessary. Extraction cleaning might dissolve water-based glue. Pay attention to temperature and amount of cleaning fluid.
